# 2024–2025 Verification Worksheet Dependent Student

Your 2024–2025 FAFSA was selected by the U.S. Department of Education for review in a process called *verification*. The law states that before awarding federal student aid we should ask you to confirm the information you and your parent(s) reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid office at Hollins University. We may ask for additional information. If you have questions about this process, please contact us as soon as possible so that your financial aid will not be delayed.

## **B. DEPENDENT STUDENT'S FAMILY SIZE**

Family Size Includes the Following:

- The student
- The student's parents, even if the student is not living with them. Exclude a parent who has died or is not living in the household because of separation or divorce. Include a parent who is on active duty in the U.S. Armed Forces apart from the family.
- The student's siblings if the following are true:
  - o They live with the student's parents (or live apart because of college enrollment),
  - o They receive more than half of their support from the student's parents, and
  - o They will continue to receive more than half their support from the student's parents during the award year.
- Other persons if the following are true:
  - o They live with the student's parents,
  - o They receive more than half of their support from the student's parents, and
  - They will continue to receive more than half of their support from the student's parents during the award year.

The provided criteria for "dependent children" or "other persons" align with the requirement that family size align with whom the parent could claim as a dependent on a U.S. tax return if the parent were to file a U.S tax return at the time of completing the 2024-2025 FAFSA. As a result, the parent should not include any unborn children in the family size. *If more space is needed, attach a separate page with the student's name and ID number at the top.*

# C. Dependent Student's Income Information to Be Verified

## 1. TAX RETURN FILERS:

# **Additional Notes:**

An individual who filed an amended federal income tax return for tax year 2022 must provide a <u>signed</u> copy of the 2022 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS, in addition to the tax documentation requested on pages 2 or 3 of this worksheet.

An individual who was the victim of IRS tax-related identity theft must provide:

- A Tax Return DataBase View (TRDBV) transcript obtained from the IRS, or if unable to obtain a TRDBV, an equivalent document provided by the IRS (or a copy of the signed 2022 income tax return and applicable schedules the individual filed with the IRS); and
- A statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.

An individual who is required to file a 2022 IRS income tax return and has been granted a filing extension by the IRS beyond the automatic six-month extension for tax year 2022, must provide:

- A signed statement listing the sources of any 2022 income and the amount of income from each source;
- A copy of the IRS's approval of an extension beyond the automatic six-month extension for tax year 2022;
- A copy of IRS Form W–2 for each source of employment income received or an equivalent document for tax year 2022; and
- If self-employed, a signed statement certifying the amount of the individual's Adjusted Gross Income (AGI) and the U.S. income tax paid for tax year 2022.

A tax filer who filed an income tax return with a tax authority other than the IRS may provide a signed copy of his or her income tax return that was filed with the relevant tax authority. However, if we question the accuracy of the information on the signed copy of the income tax return, the tax filer must provide us with a copy of the tax account information issued by the relevant tax authority before verification can be completed.
