C. INDEPENDENT STUDENT'S INCOME INFORMATION TO BE VERIFIED *Important Note: The instructions below apply to the student and spouse (if the student is married). Notify the financial aid office if the student and spouse filed separate IRS income tax returns for 2023 *or* had a change in marital status after December 31, 2023.

1. TAX RETURN FILERS:

The transcript is generally received within 10 business days from the IRS's receipt of the online request.

• <u>Get Transcript Online</u> – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript." Follow the instructions to create an ID.me account if you do not already have one. If you need help creating an ID.me account or verifying your identity, visit the ID.me IRS Help Site.

• <u>Automated Telephone Request</u> – 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.

• <u>Paper Request Form</u> – IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form

Additional Notes: An individual who filed an amended federal income tax return for tax year 2023 must provide a signed copy of the 2023 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS, that includes the change(s) made by the IRS, in addition to the tax documentation requested on pages 2 or 3 of this worksheet. An individual who was the victim of IRS tax-related identity theft must provide: A copy of the signed 2023 income tax return and applicable schedules the individual filed with the IRS, or ٠ an equivalent document provided by the IRS; and An IRS 4674C letter (a letter from the IRS acknowledging the identity theft) or a statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft, and the IRS is aware of it. However, if we question the accuracy of the information on the signed copy of the income tax return, the tax filer must provide us with a copy of the tax account information issued by the relevant tax authority before verification can be completed.
